INVESTING IN THE MALDIVES TOURISM SECTOR

October 24, 2007



The Maldives was largely terra incognita for tourists until the early seventies. Strewn across the equator in the Indian Ocean, the Maldives archipelago possesses an exceptionally unique geography as a small island country. Nature has fragmented the archipelago into 1,190 tiny islands that occupy a mere one per cent of its 90,000 sq km territory. Only 185 islands are home to its 300,000 population, while the other islands are used entirely for economic purposes of which tourism and agriculture are the most dominant.

The emergence of tourism in 1972 transformed the economy of the Maldives, moving rapidly from the dependence on the fisheries sector to the tourism sector.

Just in three and a half decades, the industry has become the main source of income and livelihood of the people of the Maldives. Tourism is also the country's biggest foreign currency earner and the single largest contributor to the GDP.

Today, there are 89 resorts in the Maldives with a bed capacity of over 17,000, providing world class facilities for tourists whose annual arrival figure exceeds 600,000. The main markets for the Maldives are the UK, Italy, Germany, France, Japan and Switzerland which together account for 78 per cent of the total arrivals. China, Russia and India occur among the emerging markets, while Japan and Korea are among the leading markets in the Asian region.

The tourism industry of the Maldives is in the hands of the private sector, and operates in a free market economy where the Government acts as the regulator and the facilitator. The growth and success of the industry is anchored in this healthy public-private partnership where roles remain clearly defined.

The tourism industry continues to attract foreign investment to the Maldives. The reasons for it are obvious: the return on investment is exceptionally high; the entire profit can be repatriated; the beauty of the islands and their surrounding lagoons and reefs are beyond description; the weather is sunny all year round; the procedures for foreign investment are simple and transparent; the foreign investment regulations are inviting and straight forward; there is political stability and civil peace; and the tourism policies of the Government are in harmony with nature and sustainable development.

Consequently, foreign parties are involved in over 57 per cent of the resorts, figuring either as the lease holder or joint venture partner of the investments, or as the operator of the resorts.

Foreign investments in the tourism industry stretch across not only resort islands, but also across safari and live-aboard vessels. With its huge potential, live-aboard vessels have begun to show signs of sharp increase in the past couple of years.

There are a number of international hotel chains such as Four Seasons, Hilton, Club Med, Taj, Banyan Tree and One & Only operating resorts in the Maldives. More international parties are either negotiating to take over resort properties or are in the process of developing resorts in the country.

Investment opportunities in the Maldives tourism industry have remained open for foreigners since its beginning. The reputation of the Maldives as a world class tourist destination has generated greater enthusiasm for investing in tourist resorts in the Maldives. Yet, as bed capacity increase is a carefully planned exercise by the Government, a determined number of islands are released at intervals for resort development creating a race for opportunities.

Currently, a total of 50 Resorts/Hotels with **8782** beds are in the development pipeline, and are at the various stages of development. It is expected that these resorts will be in the operation by 2010.
